ARTICLES OF INCORPORATION

OF

UTAH HANG GLIDING ASSOCIATION

The undersigned, a natural person over the age of eighteen years, acting as incorporator under the Utah non-profit corporation and cooperative association act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I-NAME

The name of the corporation is The Utah Hang Gliding Association.

ARTICLE II-DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE III-PURPOSE

The purpose of organizing the corporation is to promote the practice and safety of the sport of hang gliding and not for profit of the corporation.

ARTICLE IV-MEMBERS

The corporation has members and shall be open to membership, subject to the By-Laws of the corporation.

ARTICLE V-STOCK

The corporation shall issue no stock.
